What is a "Join Code" and how do I receive one?

Answer: A join code is a specific code, given to you by your AP teacher, that allows you access to classroom resources and is the first part of the two-part process of *exam* registration. You need a College Board account to join your AP class section and register for AP Exams. If you don't already have an account, please sign up. <u>College Board Log-In</u>

Does "joining" the class on the College Board website mean I MUST take the exam?

Answer: NO. Joining your class does not mean you MUST take the exam. If you do not wish to take the AP Exam, please email Mrs. Long: <u>dmlong@capousd.org</u> by Nov. 1st, 2024

Why do I have to register on College Board (CB) and Total Registration (TR)?

Answer: YES! College Board's system does not accept payment, and this is why we need two systems. Total Registration

What's the difference between College Board (CB) and Total Registration (TR)?

Answer: Joining your AP course through College Board populates your exam information. Registering through Total Registration completes the process including exam payment. Payment for exams will be handled entirely through Total Registration. NO payment will be taken on campus. Please make sure that you use the same personal, external email address (not a capousd email) for both CB and TR.

Why do I have to use my personal email for Total Registration and College Board, not my school email?

Answer: Your capousd.org email address is for login purposes <u>only within CUSD</u>. It does not receive mail. College Board and Total Registration will send important email communications, and you need to receive them. **NOTE: please use the SAME personal email in both systems, and be sure you can access it!**

What do I do if I forget my login information for my College Board Account?

Answer: Please use either the reset password option or call College Board directly. <u>DO NOT</u> <u>create a new account</u>. All of your AP and SAT scores should be linked to one single account. You may call for account assistance or linking multiple accounts at (866) 315-6068.

Will exams be in person or online?

Answer: It is College Board's intention for exams to be administered in person. Updates will be provided as soon as we receive them.

What is Bluebook, and why do I need it?

Answer: Student's will be required to download the Bluebook app to their Chromebooks in order to take the fully digital and hybrid digital exams for 2025. <u>Bluebook</u>

How do I apply for a fee reduction for my AP exam?

Answer: Students who qualify for the Free and Reduced Lunch program qualify for a fee reduction. You will need to email a copy of **this year's 24-25** Free and Reduced Lunch letter to Mrs. Long. It is the student's responsibility to notify the school of a testing conflict. Please register as normal, by the Nov. 3rd deadline, and let Mrs. Long or Mrs. Thompson know as soon as you become aware you have a conflict so they can adjust.

What happens if I want to cancel my exam or decide not to test?
